



Dear 5Point Member:

This packet contains information detailing the 2021 5Point Credit Union Scholarship Program. Please complete the application, attach all required documentation and forward the packet to your high school guidance counselor for submission to 5Point Credit Union. The completed application and required documentation **must** be mailed to the credit union **by your high school or homeschool director** and postmarked no later than **April 1, 2021** to be eligible for consideration.

The 2021 5Point Scholarship Program offers a total of twelve \$1,000 scholarships. Scholarships will be awarded to applicants on the basis of academic performance and other factors related to school and community involvement. 5Point Credit Union's scholarship committee will review all applications in the month of April. Winners will be notified of their selection shortly thereafter. Funds will be disbursed to scholarship recipients after 5Point Credit Union receives the scholarship recipient's proof of registration from their selected college or university.

**The following minimum requirements have been established to qualify for a scholarship:**

- The applicant must be a member in good standing with 5Point Credit Union. Applicant must be the primary owner of a 5Point share (savings) account in existence by March 25, 2021; parents' accounts are NOT sufficient.
- The applicant must be a graduate of an accredited high school program during the 2021-2021 academic year. Homeschool programs will be accepted on a case by case basis. Please email [info@5point.org](mailto:info@5point.org) for information regarding accepted homeschool programs.
- The applicant must be accepted by March 25, 2021 for admission as a freshman to an accredited college, university, or equivalent institution for the Fall 2021 semester.
- The applicant must submit an SAT score and/or an ACT score.
- The applicant must have an overall "C" grade point average or better.
- The applicant must have demonstrated character in dealing with people during their academic career.
- The applicant must show potential for becoming a contributing member of society.

**Applicants may not:**

- Be children or grandchildren of employees, officers, or board members of 5Point Credit Union.

It is recommended to turn in your application early to avoid missing the deadline.
  
- \_\_\_\_\_ Is your counselor's office mailing the scholarship application? Applications must be mailed directly from the applicant's school to be eligible for consideration. The only exception to this rule is homeschooled applicants.

If the answer is "no" to any of these questions, your application is incomplete.
